



NOTICE FOR E-ADMISSION CERTIFICATE

PHYSICAL ENDURANCE AND MEASUREMENT TEST (PE&MT) OF THE SHORTLISTED CANDIDATES FOR RECRUITMENT TO THE POSTS OF HEAD CONSTABLE (MIN.), IN DELHI POLICE EXAMINATION-2025.

The Physical Endurance and Measurement Test (PE&MT) for the shortlisted candidates for the post of **Head Constable (Ministerial)** in Delhi Police Examination-2025 will commence from **31.07.2026 (Friday)**.

In addition to the instructions contained in the earlier notice, candidates are once again advised to read the following instructions carefully and comply with them strictly to avoid any inconvenience or disqualification during the PE&MT.

- 1) **e-Admit Card:** Candidates must bring a printed copy of their **e-Admit Card/e-Admission Certificate**. The e-Admit Card can be downloaded by clicking the above-mentioned link.
- 2) **Photographs and Identity Proof:** Candidates must bring **ten (10) recent passport-size colour photographs** and **at least one original photo identity proof** bearing their complete date of birth, failing which they will not be permitted to appear in the PE&MT. The following documents are acceptable as identity proof:
 - a. Passport
 - b. Aadhaar Card
 - c. Driving Licence

- d. Service Identity Card (for Ex-servicemen/Government Employees)
- e. Identity Card issued by a University/College/School
- f. Voter ID Card
- g. PAN Card
- h. Ex-serviceman Discharge Book issued by the Ministry of Defence
- i. Any other photo identity card issued by the Central or State Government

- 3) **Original Documents:** Candidates must bring the original copies of all applicable documents, such as educational certificates, caste certificate, EWS certificate, Driving Licence, hill area certificate, sports certificate, Delhi Police Ward certificate, Departmental Candidate certificate, NCC certificate, RRU certificate, etc., along with **one set of self-attested photocopies** of all such documents.
- 4) **Submission of Original Documents:** No benefit, reservation or relaxation shall be granted without production of the original documents. Candidates failing to produce the required original documents shall be treated as **disqualified**, and ***no additional time or extension will be granted to produce the same.***
- 5) **SC/ST/OBC/EWS Certificates:** Candidates claiming reservation under the **SC/ST/OBC/EWS** categories must ensure that they fulfil the eligibility conditions as **on the crucial date** prescribed in the Examination Notice. ***They must produce the relevant certificate in the prescribed format given in the Annexure to the Examination Notice. Certificates in any format other than the prescribed format will not be accepted.***
- 6) **Ex-Servicemen (ESM):** Ex-Servicemen who are still serving in the Armed Forces must produce a **No Objection Certificate (NOC)** in the prescribed format, clearly indicating their date of discharge. Candidates who have already been discharged must produce their **Discharge Book/Discharge Certificate** along with the prescribed undertaking.
- 7) **Pregnant Female Candidates:** Female candidates who are pregnant, have recently given birth, or have suffered a miscarriage at the time of the PE&MT may not be permitted to participate in the Physical Endurance Test and shall be declared **temporarily unfit** until the confinement period is over, as provided in the Examination Notice. Such candidates must submit an application along with supporting medical documents at the PE&MT venue on their scheduled date.
- 8) **No Change of Schedule:** No request for change of the date, reporting time or venue of the PE&MT will be entertained under any

circumstances. Candidates who fail to appear on the scheduled date, time and venue shall be treated as **ABSENT**, and no request for another opportunity, whether submitted by post, by hand, through email or by any other mode, will be considered.

- 9) **Eligibility:** Candidates are advised to ensure that they fulfil all the eligibility conditions and meet the prescribed PE&MT standards for the post as mentioned in the Examination Notice available on the SSC website: <https://ssc.gov.in>.
- 10) **Travelling Expenses:** No Travelling Allowance (TA) or any other expenses will be paid by Delhi Police for attending the PE&MT.
- 11) **Risk and Liability:** Delhi Police shall not be responsible for any accident, injury, loss or damage that may occur during the PE&MT and shall not be liable for any claim arising therefrom.
- 12) **Physical Endurance Test:** Only those candidates who qualify in the **Race** will be allowed to participate in the **Long Jump** and **High Jump** events. Candidates will be given **three attempts each** to qualify in the Long Jump and High Jump. No appeal against disqualification in the Race, Long Jump or High Jump shall be entertained.
- 13) **Physical Measurement Test (PMT):** The Physical Measurement Test (PMT) will be conducted only for those candidates who successfully qualify in all the events of the Physical Endurance Test, namely **Race, Long Jump and High Jump**.
- 14) **Prohibited Articles:** Candidates are advised **not to bring any valuables, firearms, sharp objects, mobile phones or any electronic gadgets** to the PE&MT venue. Delhi Police shall not be responsible for the loss of any personal belongings.
- 15) **Malpractice:** Any candidate found indulging in impersonation, unfair means or any other malpractice at any stage of the PE&MT shall be **disqualified forthwith**, and further action may be taken as deemed appropriate.
